Training Options:

2-Week Puppy Boot Camp / Training Refresher

Our 2-Week Puppy Boot Camp is a great way to give your puppy a strong start with basic obedience, socialization, and good habits. Using positive, reward-based training, we focus on building confidence and creating a fun learning experience for your puppy.

During their stay, puppies will work on foundational commands such as COME, SIT, DOWN, HEEL, and an introduction to STAY. We also focus on socialization with other dogs, proper manners, and potty-training routines to help set them up for success at home. This program is recommended for puppies 6 months of age and older.

At the end of the program, you'll receive a video of your puppy demonstrating their new skills, along with recommendations for any training tools that may help you continue their progress at home.

Our 2-Week Training Refresher is designed for dogs that have already completed one of our training programs but need a little tune-up. Life gets busy, and sometimes training falls by the wayside. This refresher course helps get your dog back on track by reinforcing their obedience skills and rebuilding consistency through daily training sessions.



Plan A: Basic Obedience

Our 30-Day Basic Obedience Program is designed around your dog and the goals you have at home. Whether you're dealing with jumping, pulling on the leash, not coming when called, or just want a well-mannered companion, we tailor the training to fit your needs.

All training starts on leash so your dog can build a strong foundation and clearly understand what is being asked of them. Throughout the program, your dog will learn commands such as COME, SIT, STAY, PLACE/BED, NO, and HEEL, along with crate training, good manners, and everyday household expectations. As your dog progresses, we also begin working toward off-leash reliability whenever possible.

At the end of the 30 days, we'll spend one-on-one time with you and your dog, showing you everything they've learned and making sure you feel confident continuing their training at home. We want both you and your dog set up for success. An in-home follow-up session can also be scheduled after the recommended two-week transition period.

Included: Room and board, daily exercise, and personalized one-on-one training every day.

Plan B: Advanced Obedience

Our 60-Day Intermediate Obedience Program takes everything learned in the first 30 days and builds it into reliable, real-world obedience. This program is perfect for owners who want more consistency, better focus around distractions, and the freedom that comes with dependable off-leash control.

Your dog will continue strengthening commands such as COME, SIT, STAY, PLACE/BED, NO, and HEEL while progressing from on-leash work to off-leash reliability. We focus on creating clear communication, confidence, and consistency so your dog understands how to respond whether at home, on walks, or in more distracting environments. Crate training, manners, and any specific goals you have for your dog will continue to be reinforced throughout the program.

For clients who are interested, we also offer e-collar training as a communication tool to help achieve a higher level of off-leash reliability and freedom. Many of our clients describe this program as life-changing because it allows them to enjoy more activities with their dog while feeling confident in their dog's responsiveness.

At the end of the 60 days, we'll spend one-on-one time with you and your dog, showing you everything they've learned and making sure you feel comfortable continuing the training at home. An in-home follow-up session can also be scheduled after the recommended two-week transition period.

Included: Room and board, daily exercise, and personalized one-on-one training every day.

Note: Required food, vaccinations, heartworm preventative and parasite control are at the owner's expense; any needed vet care is at the owner's expense including trip charges. Any poodle mix dog needs to be cut short before entering our programs. This includes, but not limited to, labradoodle, goldendoodle, aussiedoodle, berniedoodle, borderdoodle, etc.



LIABILITY WAIVER & POLICIES

By signing below, I acknowledge and agree to the following terms and conditions regarding the care, boarding, daycare, training, transportation, and handling of my dog(s) by RW Canine Retreat:

1. ASSUMPTION OF RISK

I understand that participation in boarding, daycare, training, playgroups, outdoor activities, walks, exercise, transportation, and interactions with other animals and the environment carries inherent risks that cannot be completely eliminated despite reasonable care and supervision.

These risks include, but are not limited to:

- Dog bites or scratches
- Injury during play
- Illness, parasites, or contagious conditions
- Escape attempts
- Exposure to insects, wildlife, snakes, spiders, bees, ticks, or other animals
- Uneven terrain, outdoor hazards, fencing failures, or acts of nature
- Stress-related illness or injury
- Injury, illness, allergic reactions, or death

I voluntarily accept and assume all risks associated with my dog's participation in services provided by RW Canine Retreat.



2. STANDARD OF CARE

RW Canine Retreat agrees to exercise reasonable care in handling and caring for all dogs entrusted to its care. However, I understand that no amount of supervision or precaution can guarantee my dog's absolute safety.

I understand and agree that RW Canine Retreat, its owners, employees, contractors, and representatives shall not be liable for injuries, illnesses, death, loss, damages, or expenses resulting from accidents, unforeseen events, acts of nature, wildlife encounters, or other incidents that occur despite reasonable care and supervision.

3. OWNER RESPONSIBILITY

I certify that my dog is healthy, properly vaccinated, and free from any known condition that would make participation unsafe.

I accept full responsibility for any property damage, injury, illness, veterinary expense, or other costs caused by my dog's actions while under the care of RW Canine Retreat.

I agree to indemnify, defend, and hold harmless RW Canine Retreat, its owners, employees, and agents from any claims, liabilities, damages, costs, attorney fees, or expenses arising from my dog's behavior or participation in services.



4. EMERGENCY MEDICAL CARE

In the event of illness, injury, or emergency, I authorize R W Canine Retreat to seek veterinary care for my dog at its discretion if I cannot be reached immediately.

I authorize treatment by my listed veterinarian or an alternate licensed veterinarian chosen by R W Canine Retreat if necessary.

I understand and agree that:

- All veterinary expenses are my responsibility;
- I will reimburse RW Canine Retreat for any emergency medical expenses incurred on my behalf;
- RW Canine Retreat is not financially responsible for outcomes related to emergency veterinary treatment obtained in good faith.

This includes, but is not limited to:

- Office visits
- Emergency care
- Antivenom treatment
- Medications
- Surgery
- Hospitalization
- Diagnostic testing
- Transportation costs



5. LIMITATION OF LIABILITY

To the fullest extent permitted by Texas law, the liability of RW Canine Retreat for any claim arising out of services provided shall not exceed the amount paid by the owner for services during the current boarding or daycare stay.

Under no circumstances shall RW Canine Retreat be liable for indirect, incidental, special, or consequential damages.

6. AGGRESSIVE OR DANGEROUS DOGS

RW Canine Retreat reserves the right to refuse service, isolate, muzzle, transport, or remove any dog displaying aggressive, unsafe, destructive, or dangerous behavior.

I understand that dogs are animals and unpredictable behavior may occur even in previously non-aggressive dogs.

7. ABANDONMENT

If my dog is not picked up within 10 days of the scheduled pickup date and I have made no communication or arrangements, RW Canine Retreat may consider the dog abandoned and may surrender the dog to animal control, rescue, or another appropriate authority.

8. PHOTO & SOCIAL MEDIA RELEASE

I grant permission for RW Canine Retreat to photograph or video my dog for business, marketing, and social media purposes without compensation.



9. ENTIRE AGREEMENT

This agreement constitutes the entire understanding between the parties and supersedes prior agreements or discussions.
